## Branch Protests NY Post Cartoon

Last month the San Antonio Branch NAACP staged a local protest over the racially offensive cartoon published in the New York Post in February. The action was part of the National NAACP Day of Action organized to encourage changes at the Post to prevent recurrences of similar examples of racial insensitivity and inappropriate provocation at the Fox Corporation newspaper.

On February 26th members of the Branch were joined at KABBTV, the local Fox television affiliate, by representatives of the faith-community, and supporters from the local AFL-CIO to solicit the support of the station. Branch 1<sup>st</sup> Vice President, Horace Brown, Jr., delivered a letter to the general

manager and later read a statement at an on-site press conference. KABBTV is an independent consumer of Fox News programming.

The cartoon showed police shooting an ape with a caption

saying, "I guess they'll have to find someone else to write the next stimulus bill." It was displayed next to a photo of President Obama signing the stimulus package. Both Fox News and the New York Post have come under criticism by a variety of media watchdog groups for racially insensitive and biased reporting.

"It's an invitation to the assassination of the 44<sup>th</sup> president," said Benjamin Todd Jealous, President and CEO, NAACP National Office. Furthermore, "Likening our African American president to a monkey is unacceptable. African Americans have for too long been called primates as a way of dehumanizing an entire race of people. It's time for this pattern at Fox News to stop." Jealous noted.

## NAACP Lending Lawsuit Advances

A federal court has denied a joint motion filed by 15 major financial institutions seeking to dismiss the NAACP's landmark lawsuit challenging racial discrimination in sub-prime home mortgage lending. The court found that the NAACP had standing to bring the lawsuit, and that it had adequately stated its claims for the lawsuit to

proceed. The lenders will now be required to turn over information and documents regarding their mortgage policies and practices.

According to the lawsuit, African American homeowners who received mortgage loans had a more than 30 percent greater likelihood of being issued a higher rate sub-prime loan than

Caucasian borrowers with the same qualifications. The Federal Reserve Board, U.S. Department of Housing and Urban Development, and FDIC have all made similar observations.

The NAACP brought the suit as part of its longstanding demand that offending lenders stop discriminatory practices.

## National NAACP Celebrates 100 Years

On February 12, 2009, the NAACP celebrated its 100th anniversary—which coincided with the bicentennial of Abraham Lincoln's birth—marking another milestone in the history of African American achievement in the United States.

The NAACP was formed partly in response to the continuing horrific

practice of lynching and the 1908 race riot in Springfield, the capital of Illinois and birthplace of President Abraham Lincoln. Appalled at the violence that was committed against blacks, a group of white liberals that included Mary White Ovington and Oswald Garrison Villard, both the descendants of abolitionists. William English Walling and Dr. Henry

Moscowitz issued a call for a meeting to discuss racial justice. Some 60 people, seven of whom were African American (including W. E. B. Du Bois, Ida B. Wells-Barnett and Mary Church Terrell), signed the call, which was released on the centennial of Lincoln's birth. [Find a more complete NAACP history at: [naacp.org](http://naacp.org).]


### Branch Celebrates 91<sup>st</sup> Anniversary


