National Convention

The 99th Annual NAACP Convention was highlighted by the appearances of the incoming President and CEO, Benjamin Jealous, and presumptive presidential nominees, Senators Barack Obama and John McCain. Julian Bond, Chairman of the National Board, delivered remarks

emphasizing the importance of all Branches being vigorously engaged in voter registration and get-out-the-vote (GOTV) efforts this election season. Dennis C. Hayes, Interim President, spoke on the issue of flying the confederate flag in South Carolina. He indicated that the NAACP is developing an action plan that

will be revealed soon. A debate was held on Monday evening pitting youth teams from Stockton, California and Detroit, Michigan arguing the issue of universal healthcare. Nate Parker, the actor from "The Great Debaters" was one of the judges. Stockton won the contest. Region VI voted to only send one name for election to the National Board. Gary Bledsoe's name will be submitted for re-election.

NAACP Fights Predatory Lending

NAACP units across the country participated in a national 'Day of Action' against discriminatory mortgage lending today by demanding that several of the nation's top lenders – including Citi, HSBC, WaMu, GMAC and JP Morgan – make amends for discriminating against African American borrow-

ers and eliminate discriminatory policies and practices for good.

According to the NAACP and its lawsuit against 17 major lenders, African American borrowers were given loans with higher interest rates and other poor terms solely because of their race.

"Every one of us deserves equal access to the

'American dream' of homeownership," said NAACP Interim General Counsel Angela Ciccolo. "Making amends is just the beginning. We want to make sure African Americans are never victimized by the lending industry again. This discrimination was nationwide and cut across income-levels. People with six-figure incomes, significant down-payments and who had owned several homes."

NAACP Pushes for SAPD Changes

During 2007 the San Antonio Police Department found itself having to explain an unusually high number of police-involved shootings. In her August 13, 2007 column in the San Antonio Express-News entitled "Lawlessness Hurts Everyone," Kathy Clay-Little argued for an investigation of SAPD's practices and policies. The challenge had indeed been made and was readily accepted by the local NAACP along with the ACLU, LULAC, and other like-minded organizations. As a result, the

San Antonio Coalition on Human and Civil Rights was formed. Early on, the NAACP served as the host for the coalition's meetings, providing a meeting site and lunch. The focus of this coalition of activists is on "use of force incidents," the handling of citizens' complaints, and the effects of the SAPD's collective bargaining agreement on the process. Having been duly authorized by the local body to partnership with other human rights organizations, the local branch can

take credit for its role in forcing police Chief McManus to ask the City Council to hire an outside firm to look into SAPD's policies and practices. In November 2007 the Police Executive Research Forum (PERF) was hired by the City Council for that purpose. The NAACP has been well represented on the coalition by President Howard Anderson, William B. Johnson, Lloyd Miller, and Oliver Hill. Now that PERF has submitted its findings and recommendations,

perhaps the most difficult tasks lie ahead for the coalition of ensuring the implementation of PERF's recommendations.

Digital TV Conversion


On February 17, 2009, all television broadcasts throughout the United States will be solely digital. This means that after that date, all people who still use the old "analog" system, or those who continue to receive their television signals through "rabbit ears" or a rooftop antenna, will need either televi-


sions already equipped with digital tuners or add a "digital-to-analog" converter device to their TV sets.

The NAACP is working with federal government agencies as well as several other non-profit groups to try to help educate and prepare our communities about this impending change, and that there are steps that can

be taken to reduce the cost to affected consumers. The federal government will issue coupons to reduce the cost of a converter box to consumers for up to two televisions per household by \$40 per coupon.
